# **Trailside Planting Project**

he D&H Rail-Trail Swale project on April 29 (rain date May 6) took place in order to improve a trail section surrounded by wetlands in Ararat that was damaged by beaver activity, flooding, and climate change. Volunteers planted trees, perennials and shrubs as service berry, dogwoods, Joe Pye Weed, winterberry, swamp rose, meadowsweet and other native plants. The project was funded by the Department of Environmental Protection 2022 Environmental Education Grants Program with guidance from Penn State Extension

Staff, Susquehanna County Conservation District, and the Rail-Trail Council of NEPA. Volunteers also learned about habitat enhancement, living with beavers, climate change, watersheds, tree identification, and more. Free tree seedlings went to the first 25 registrants! Volunteers received a certificate for community service hours. A bench was built and donated by the students at Susquehanna County Career and Technology Center for this trailside peaceful area.





The mining of anthracite coal and its transport over the rails is a fascinating relationship that evolved together and led to the growth of the Forest City Area. Also, the history of immigration to the United States and this area is closely linked to the history of railroads and coal mining.

The Forest City area in the 1860s was densely covered with stately hemlocks and known as Forest Mills. Lumbering attracted settlers to the area as there was a need for loggers and bark peelers—hemlock bark being used to produce tannic acid, for tanning hides for leather goods. In 1864, William Pentecost and his family moved from the Prompton area to conduct an extensive lumbering business. He purchased the standing hemlock on the D&H Canal Company tract. The D&H had purchased much land in the 3-county area around 1857 for lumbering and had erected mills along the Lackawanna River. One early D&H mill was at the outlet from Stillwater; another mill was located near Castle Garden, Browndale.



Forest City is considered the northern gateway to the anthracite coal fields.

As railroads grew in popularity, the canal company recognized the importance of replacing the canal and gravity system with a railroad. D&H managers signed a contract with the Erie Railroad for the construction of a railroad between Carbondale and Lanesboro. The Erie Railroad would own the tracks, known as the Jefferson Branch, and lease to the D&H, who would be responsible for track maintenance and dispatching.

The 35-mile "Jeff" from Carbondale to Lanesboro was constructed in 20 months! It was bid out in 32 sections—contractors could bid on one or more sections. The chief engineer was Scotsman Bryce Blair, who is buried in the Maplewood Cemetery, Carbondale.

During the construction of the "Jeff" in 1869, large outcroppings of coal were discovered. Since both the Erie Railroad and the Delaware & Hudson Canal Company owned large tracts of land around Forest City, coal mining became an important business. Even though the Erie and D&H shared the same railroad track, they were fierce competitors in coal mining, processing, and transportation.

The railroad was also known as the Jefferson-Ararat Railroad, as the steep grade was well-known to railroaders and was defined by the powerful engines needed to transport coal out of Carbondale to its high point in Ararat. In its heyday, the Jefferson Branch was the mainline from the coal regions of Northeastern PA with one D&H freight train every hour either north or south—24 trains a day. The Erie used it as a branch line and had 3-5 trains per day.

The largest collieries (coal-processing plants with mines, breakers and rails) in the area were owned and operated by the railroads. The Hillside Coal & Iron Company, owned by the Erie Railroad established the first commercially profitable coal mining enterprise at North Railroad Street (Babe Ruth Park and Yucca Flats area). It was known as the Clifford Colliery and had a very productive mine shaft with very pure anthracite found in thick veins. Mining of this shaft brought a large influx of immigrants to the area. The Erie also owned other mining operations as the Forest City Colliery, located where the post office is now.

The D&H Railroad mined and operated as Hudson Coal Company with Clinton Colliery as its largest operation. Many remains can be seen off both sides of the trail just south of the Forest City Trailhead. The supervisor was Abraham Vandling, for whom the town was named. It produced 15.3 million tons of coal during its 50-year lifetime. (*To be continued next issue.*)
